The Crisis Event
Date: July 12, 2025 Location: Private residence, Kissimmee, FL area
Situation: Adult son (30 years old, high-functioning Asperger's)
experiencing meltdown
with verbal aggression toward parents. Father used light touch to
redirect. Police
interpreted as assault. Arrest followed despite son's immediate
clarification to officers:
"Why are you taking my daddy away? He only disciplined me—I was
wrong!"

Outcome: 4-month incarceration, PFA order, permanent family

separation. No disability
context considered.

What Broke: Response Gaps

Root Cause Analysis

Primary Failure: Law enforcement lacks mandatory disability advocate
dispatch when
autism/PTSD indicators present.

Secondary Failure: Judicial PFA process skips context documentation
requirements.

Systemic Gap: No "pause protocol" training for high-stress family
interventions.

Proven Crisis Leadership Context

- 25+ years: FEMA deployments, American Red Cross, MDR Disaster Relief
(144 missions, 4 as National Disaster President)
- Personal validation: Survived heart attack during incarceration;
cared for by
compassionate officers showing correct response model

Prevention Protocol: 5 Immediate Fixes

1. Law Enforcement Dispatch Protocol

Autism/PTSD Indicators → IMMEDIATE disability advocate dispatch
Verbal aggression + physical redirect → DOCUMENT CONTEXT before
handcuffs

Family clarification statements → BODY CAM REQUIRED

2. Judicial Safeguards

PFA hearings → REQUIRE police report + advocate testimony
Caregiver syndrome documentation → MANDATORY consideration
Disability context → 48-hour review period

3. Heaven-Sent Response Model

24/7 CRISIS HOTLINE → Advocate dispatched within 8 minutes
FAMILY STABILIZATION TEAM → On-scene within 20 minutes
NO-JUDGMENT intervention → Immediate de-escalation focus
